The 2023 IALD award recognises the lighting design of the hotel reception, lobby lounge, and wine bar, designed in collaboration with lighting design firm 'Nipek'. Setsu Niseko is also one of just seven projects in the world shortlisted for the "Best New Ski Hotel" at 'The World Ski Awards' with the results set to be unveiled in November 2023.
